TERMS AND CONDITIONS

1. Gift Card Sale Information

- a. Each gift card is good for \$15 worth of car wash services at any Big Splash Car Wash location.
- b. The Organization must meet the minimum gift card order requirement of (50) unless otherwise noted here _____.
- c. The cost of the gift cards to the Organization is \$7.50 each. See Section 2 for payment details.
- d. The recommended resale price of the gift cards is \$15.
- e. The gift cards do not expire.

2. Payment

The gift cards must be acquired in advance from the corporate office of Big Splash Car Wash, with Organization Contact providing Payment in the form of check, money order, credit card or cash/debit card in the amount of 50% of the value of the gift cards obtained on behalf of the Organization.

- a. We accept Visa, MasterCard, and American Express.
- b. Certified Check/Money Orders: Payment via certified check or money order should be made payable to Big Splash Car Wash and delivered to the following address: Big Splash Car Wash, 8100 Metcalf Ave, Overland Park, KS 66204.

3. Proceeds The Organization is responsible for collecting all proceeds from the resale of the gift cards and is responsible for complying with all applicable tax laws, rules and regulations.
4. Unsold Gift Cards Unsold gift cards may be returned to Big Splash Car Wash on or before the Agreement End Date and will be refunded in the amount of 50% of the value of the cards. Big Splash Car Wash is not responsible for lost or stolen gift cards.
5. Restrictions
 - a. Gift cards obtained through this Agreement may not be sold within 500 feet of any Big Splash Car Wash location.
 - b. Gift cards obtained through this Agreement may not be sold or advertised online.
 - c. Gift cards obtained through this Agreement may not be sold used for personal use, donated or given away. They must be sold in accordance with Section 1 above.
